Who we are

Supplementary Packages - SARS Support



Like our payroll packages, our tax support options are only currently available in South Africa. But if you are in South Africa and correspondence from SARS strikes fear into your heart, these are for you.

Like our payroll and accounting packages, our SARS Support services come with three package options.

Like payroll, if you elect to do your own bookkeeping and just want us to be your buffer against the taxman, then these packages can be taken on their own - but then you will need to tell us if you also want assistance with your PAYE and VAT submission. If you take an accounting package, then PAYE and VAT returns are included under a Grow or Thrive option.

While most tax submissions happen once or twice a year, our packages are still paid monthly - why? Mainly because breaking the payment into twelve makes it far more affordable for you! But also because everything we do is worked on a monthly retainer, so why not taxes?

All packages

All our packages, starting with Sustain, include **notifications** of deadline dates, your **tax calculations** and reports, as well as the **reconciliation** of the submission to your accounts and schedules, and - of course - your **return submission**.

This covers the absolute necessities of your compliance for you.



What's extra in Grow?

On a grow package, we will not just send notifications, but also **reminders** of your due dates! We also help with the **submission of supporting documents** (if they are required) and we will **manually follow up** on any submissions that we have made - instead of just waiting for you to let us know that SARS called or emailed you. We also do a **quarterly liability check** for you, and we get you your **tax clearance certificate** once a year.

Which leads us to Thrive

Thrive is our premium service, so it follows the pattern of all of our premium options - it is designed to take away the stress of compliance completely away from you. So it includes all the services in Sustain and Grow, with a few extras:

A **quarterly tax clearance check** - to make sure that something hasn't been overlooked and is suddenly causing you a headache.

The **submission of objections** - if we finalise a submission and SARS comes back with a fight, we handle that fight for you.

Email correspondence with SARS - questions, queries, requests for reasons, requests for documents and anything else SARS emails you, it becomes our problem.

Assistance with tax planning - we will sit down with you and assess your complete tax picture - for you and your business, and any other businesses you are involved in. The aim is to make sure you are paying the least amount of tax overall, across all of your entities.



Possible Add-on

The only possible extra service you might want, is what we call "Complete SARS Representation" - it involves us taking over every single part of your interactions with SARS.

It's not cheap, but man is it worth it. Let us know if you want to know more.

It has been our experience that when SARS decides to be difficult about a particular return or taxpayer, then resolving that issue can easily take up to 5 months, and involves almost daily follow up.
